This announcement is made by i-CABLE Communications Limited (“**i-CABLE**”) pursuant to Rule 3.7 of The Hong Kong Code on Takeovers and Mergers (“**Takeovers Code**”) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and Inside Information Provision under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong). This is a voluntary announcement of The Wharf (Holdings) Limited (“**Wharf**”).

Reference is made to the joint announcement dated 5 July 2016 published by i-CABLE and Wharf and the subsequent announcements dated 5 August 2016, 5 September 2016, 4 October 2016, 4 November 2016, 5 December 2016, 5 January 2017, 3 February 2017 and 3 March 2017 published by i-CABLE (collectively the “**Announcements**”). Unless otherwise stated, capitalized terms used herein shall have the same meanings as those defined in the Announcements.

Wharf has informed the board of Directors of i-CABLE that (i) no agreement in respect of the disposal of interests in i-CABLE has been entered into by Wharf; (ii) Wharf has terminated all discussions in relation to any disposal of interests in i-CABLE; and accordingly (iii) Wharf is not aware of any Possible Transaction which may result in an offer being made under the Takeovers Code in respect of the securities of i-CABLE.
