### POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 10 MAY 2018

At the Annual General Meeting of The Wharf (Holdings) Limited (the “Company”) held on 10 May 2018 (the “AGM”), a poll was conducted for voting on all the proposed resolutions as set out in the Notice of AGM dated 9 April 2018.

As at the date of the AGM, the total number of issued shares entitling the holders to attend and vote on all the resolutions at the AGM was 3,045,327,327 shares. There was no restriction on any shareholders to cast votes on any of the resolutions at the AGM.

The Company’s share registrars, namely, Tricor Tengis Limited, was appointed as the scrutineer at the AGM for the purpose of vote-counting. Set out below are the poll results in respect of the respective resolutions put to the vote at the AGM:
